- 1. In case a few students are absent due to health reasons or any other unavoidable circumstances or if the performance of any of the students is very poor, all such cases will be referred to a standing committee consisting of the Controller of examinations (Chairman), HoD of the concerned department members and the Academic coordinator (Convener) On the recommendation of the committee, a makeup test will be conducted on payment of fee as fixed by the examination branch.
- 2. In order to improve the attendance and to encourage the students who are regular to the college, under CIE, out of 25 marks, 20 marks are allotted to midterm examination and 5 marks for attendance, in each subject will be assigned to the students as per the percentage of attendance shown in the following table.

#### 3. Transitory Regulations:

- Discontinued, detained for attendance, detained for want of credits, or failed a) students are eligible for readmission as and when the same is offered during the subsequent academic year as per the college admission procedures.
- Students on transfer from a non- autonomous or from an autonomous college shall b) complete all the courses of the concerned programme not covered in the earlier organization. However, he/she should take the remaining courses in the programme along with the other students.

No.1: To revise the course structure of R-15 regulations of B.Tech Course, by Incorporating provision for completing a few courses in advance by the students having excellent academic record.

Tem No. 2: The existing clause no.11 in R-15 regulations is replaced with the new one. The existing and amended versions of the clause 11 are as follows,

# The present (existing) clause no.11 of the academic regulations.

# II. Registration/ Dropping

Each student has to compulsorily register for course work at the beginning of each semester as per the schedule mentioned in the academic calendar. It is absolutely recessary for the student to register for courses in time.

The student has to register for a minimum of 20 credits and may register up to a maximum of 28 credits based on the advice of the Faculty Advisor. On an average, a student is expected to register for 24 credits.

- TL3 A student at the end of II year II semester either having CGPA of  $\geq$  7.0 or having passed all previous courses in the first attempt with a minimum CGPA  $\geq$  5.0 is allowed register for an additional course/ credits from the offered open electives.
- Open Electives are offered to students, in III year I semester and II semester along with IV year I semester, which can be registered by the students during III year and IV year I sem. Prior permission for registration of Open Electives as an additional course is compulsory.
- TL5 A student would be allowed to register in an additional course only if he/ she satisfy

- IL6 Departments will notify at the time of registration about the minimum number of students to be enrolled for a particular course to be offered.
- III.7 Any student may be barred from registering for any course for specific reasons like disciplinary reasons, non- payment of fees, etc.
- **11.8** Dropping of Courses: Within four weeks after the commencement of the semester, the student may, in consultation with his/ her faculty advisor, drop one or more courses without prejudice to the minimum number of credits. The dropped courses are not recorded in the Grade Card.
- **11.9** After Dropping, minimum credits registered shall be 20.

# The Amended clause 11 of the Academic Regulations

# Provision for advanced completion of a few courses

**11.1.** With a view to give an opportunity to the students to undertake full time Internship in an industry for 3-4 months as per the guidelines of AICTE, academically bright students may be permitted to complete 3 courses of 4/2 semester in 3/2 and 4/1 semesters .

# 11.2. Registration for advanced completion of courses

A student at the end of B.Tech III year I semester and at the end of B.Tech III year II semester either having CGPA of  $\geq$  7.0 or having passed all the previous courses in one attempt with a minimum SGPA  $\geq$  5.0 is allowed to register for the theory courses in advance.

11.3. Departments will notify at the time of registration about the minimum number of students to be enrolled for the additional course(s) to be offered.

11.4. A subject/ course may be offered to the students, only if a minimum of 30 students opt for it. The maximum strength of a section is limited to 70.

## Minutes of 12<sup>th</sup> Academic Council Meeting held on 6<sup>th</sup> July 2020

Director, VJIT has invited all the members of Academic Council. The Academic Council has placed on record their thanks and appreciation to Dr. P. Venugopal Reddy the former Director, VJIT for his services rendered to VJIT.

#### **Points Discussed in the Meeting**

# 1.0 To approve Course Structure and Syllabi of B. Tech II, III and IV B. Tech courses of R-18 & R-19 Regulations

Director informed that, the BoS members of departments had meetings and finalised the Course Structures and Syllabi in the month of June 2020. The members of BoS have studied the Course Structure and Syllabi of B.Tech II,III and IV year of R-18 & R-19 regulations and approved. The same has been presented to Academic council Members.

During the meeting, a discussion on revision of course structure and syllabus of EEE was initiated by Dr. M.V. Krishna Murthy. He opined that, the Course Structure of EEE has a heavy dose of core Electrical Engineering with less proportion of Electronics. He felt that the current course structure was designed keeping in view the needs of state electricity boards and few heavy industries, but currently there are lot of opportunities in private sector for EEE students which need exposure to some basic Electronics courses. It was advised to include a few courses related to Electronics and Communication Engineering like Analog Electronics, VLSI design, Digital Signal Processing to make the course up-to-date to meet the current day challenges and to enhance the placement opportunities for the students.

**Prof** G. Tulasi Ram Das, University Nominee has suggested the following modifications in Professional **Electives of EEE**.

- PE-1: Remove the subject Electrical Estimation and Costing and add Digital Signal Processing (DSP)
- PE-2: Integrated Circuits Analysis
- PE-3: No change is required
- PE-4: Remove any one course of your choice and add Embedded System Design (ESD)

Dr. Krishna Murthy has also suggested a few modifications to the Course Structure and Syllabi of CSE, IT, AI and AI & DS.

• A Combined lab for Python and Data structures in 3<sup>rd</sup> semester. As this would/may dilute rigor of Data Structures which would need a full-time lab. A strong foundation in Data Structures is needed not only for campus placement, but also for a day-to-day work of any software engineer.

- In the case of AI & DS, 2<sup>nd</sup> Semester course has been exclusively dedicated to Data Structures, which is commonly followed in CS programmes of most universities. CS and IT can adopt the same
- It was suggested to make the language courses more lab oriented. Students should be provided variety of exercises to enhance their problem solving capability in the lab which would help them in their placements. The theory credits should be reduced and proportionally lab credits should be
- It was further expressed that the Curriculum is loaded with Language Courses, so instead of too many languages, it should encourage students to pick these Language Courses online at Coursera or similar forums. In stead of different language courses, a specific course on illustrating the differences in various programming paradigms/languages (e.g. Procedural, object-oriented,
- Dr M V Krishnamurthy & Dr Utla Balaji opined that the subject of Software Engineering may be removed or made elective for a variety of reasons. The course is very dry and a student can understand and appreciate it only if he had already undertaken some big projects. It can be taught in a meaningful way by a faculty with some industry experience who had already managed some big development projects. Most of the topics in the syllabus are not relevant to current industry practices. Because of these reasons, most of the premium institutions had already removed this
- It was also discussed by Dr M.V. Krishna Murthy and Dr Balaji Utla that, there was a need to introduce Course on Design Thinking as it has been gaining prominence. Director also felt that the Design Thinking course need to be introduced for all the branches.
- AI, AI & DS: Dr Krishnamurthy mentioned that he reviewed the course structure and syllabi of these courses twice as a BOS member and his suggestions were already incorporated.

ECE: The Members felt that ECE Course has been well designed, up-to-date and well balanced with theory and labs. In the 3<sup>rd</sup> Semester, Object Oriented Programming is taught through Java without a lab. It was suggested to have a lab component by suitably adjusting the credit structure. It was suggested to offer Electives in Cryptography and Quantum Physics. Cryptography is essential for secure communications and Quantum Physics is an emerging field and is the basis

As per the suggestions given by members, Director stated that they will be reviewed with respective members of BoS and the course structure and syllabi will be finalised. Director further informed the members that, the course structure and syllabi will be placed on the website of the Institute.

With all the above significant and valued suggestions given by the Academic Council Members, the Academic Council approved the Course Structure and Syllabus of R-18 & R-19 B. Tech II, III & IV year. Director informed the Academic Council Members that the suggestions given are highly appreciable and shall be engaged with true spirit. Director pointed out that the suggestions will be

- A student at the end of B. Tech III year I semester and at the end of B. Tech III year II semester either having CGPA of  $\geq$  7.0 or having passed all the previous courses in one attempt with a minimum SGPA  $\geq$  5.0 is allowed to register for the additional theory courses.
- The student can take one extra subject in each semester and can complete the program in 3 ½ years but the original degree will be issued along with his/ her batch mates after completing 4 years of stay in the college.
- A subject/ course may be offered to the students, only if a minimum of 30 students opt for it. The maximum strength of a section is limited to 70.

However, the student's performances in the earlier individual semesters, with the corresponding SGPA for which already Grade Cards are given, will not be altered. Further, the optional drop out for such 6 credits shall not be allowed for i) <u>Open Elective Subjects</u> ii) Laboratory Courses iii) Industrial Training / Mini Project iv) Seminar v) Major Project vi) Comprehensive Viva"
