For the enhancement of students technical, design thinking, team work and presentation skills they are encouraged to participate national and international level Hackathons.

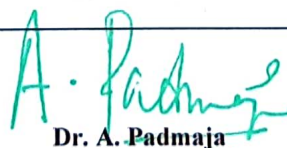
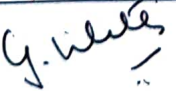
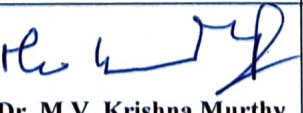
With reference to Point No 13: Training and Placement program for the students/Enhancement of Quality Placements
